## Reminder: 5500 and PCORI Due in July

#### Form 5500 Due July 31

Employers must file Form 5500 electronically with the Internal Revenue Service (IRS) and Allied National will mail your employer clients the 5500 Filing Information Worksheet. The deadline for calendar-year plans is July 31, 2024. The form is used to report information on the qualification of the plan, its financial condition, investments and the operations of the plan.



#### **PCORI Fees Due July 31**

Payment of PCORI fees is due July 31, 2024. For plan years that ended on or after Oct. 1, 2023, and before Oct. 1, 2024 (including calendar year plans), the fee is \$3.22 per person covered by the plan. For plan years that ended after Oct. 1, 2022, and before Oct. 1, 2023, the fee is \$3 per person. The PCORI fee will be in effect through 2029 and is used to fund comparative effectiveness research.
